ANNUAL VOLUNTEER APPRECIATION BANQUET RESOLUTION

WHEREAS, The Summerfield Subdivision Property Owners' Association, Inc. duly organized and existing under the laws of the State of South Carolina and hereafter referred to as the "Association"

WHEREAS, the Board of Directors, acting in accordance with the Declaration of Restrictions and Protective Covenants of the Association and within the powers granted to them by those documents

RESOLVED, in accordance with our governing documents, Article III, C, Section 18(d), grants the Board the responsibility and power to designate and hire the personnel necessary for the maintenance, operation, repair and replacement of the Association's property and common areas, and where appropriate providing compensation to such personnel.

The Association by and through the Board, has decided to implement volunteers within various committees to help with the upkeep of the Association's property and common areas instead of contracting out third party to do such. Thus, the Board has the authority to compensate personnel who provide the above services.

By the powers given to them, the Board of Directors voted and approved on November 09, 2023 the adoption of an Annual Volunteer Appreciation Banquet as a way for our community to show appreciation for the work, commitment, and dedication to our Summerfield Community. The following will clarify any outline the communities support for such an event to take place annually at a time that is convenient for both the BOD and Committee Members:

Directives of the Annual Volunteer Appreciation Banquet;

- The sole purpose of the volunteer celebration is to show support for our volunteers, show thanks for their sacrifice, and encourage others to volunteer.
- This resolution empowers the Summerfield Board of Directors the powers to plan, assemble and fund an annual Volunteers Appreciation Banquet. The celebration shall be funded using Association funds.
- Volunteers must work within a committee for a minimum of 6 months to qualify as an invitee to this event.
- At no point shall the Board approve any conditions that include the Association funds being used to pay for alcohol or the consumption of alcohol.
- Each Board is empowered as to how they choose to implement this annual event.
- The Board shall include a line item in the annual budget for this event.
- The funding for all future Volunteer Appreciation events using Association monies shall be approved by the Board and announced to the community prior to said event.
